Eligibility for food contact

We hereby confirm that the PE-film, supplied by Aspelin Group, are manufactured in accordance with the EC 2023/2006 regulation on good manufacturing practice for materials and articles intended to encounter food or food related products.

Our polyethylene products fulfill the requirements of (EC) regulation 1935/2004 and 10/2011 and 213/2018 concerning the materials and articles intended to come into contact with food related products.

Traceability

The origin of the products and materials used can be retraced by producer and grade with the documents and reports made by our production management programme/system.

Migration

Polyethylene and other possible additives used are virgin materials and they all comply to the European overall migration regulations as follows:

The monomers and additives of raw materials are consistent of regulation 10/2011/EC and amendments of that regulation; 37/2019, 831/2018, 213/2018, 79/2018, 202/2014, 174/2015 and 752/2017.

There are no constituents that exceeds any specific migration limits according to the SML 10/2011/EC Regulations or the amendments of this Regulation.

The content of heavy metals per 94/62/EC is not exceeded. No phthalates, halogen polymers, brominated or chlorinated additives have been used in the production process.

The products are produced and use Chemical particles that are aligned with the EU 1907/2006 Regulation on Registration, Evaluation, Authorization and Restriction of Chemicals intended for Human usage (REACH).

Products do not include dual-use additives nor latex.

Inks used

Aspelin Group uses only monomer free inks which are formulated and manufactured in accordance with the EuPIA Guideline, EuPIA-GMP and section 8b of Swiss Ordinance 817.023.21 as well as the EC Regulation No. 1935/2004 on Printing Inks applied to the non-food contact surface of food packaging materials and articles. All inks used in our flexographic printing are formulated without mineral oils and thus are virtually free of mineral oil hydrocarbons (MOSH and MOAH).

Quality Assurance

Aspelin Group Oy applies Good Manufacturing Practices (GMP 2023/2006 as amended by EC 282/2008 and 1906/2015) to all operations that we provide. Hygiene Control is based on HACCP and we are using quality control system which is built upon ISO 9001 principles but is not certified.

Allergens

Food ingredients listed in Annex II of EU Regulation 1169/2011, are not used in the manufacture of or formulation of these products. However, these products have not been tested for these substances.

Use

PE-products in concern are suitable for contact with all food types with exception of holding or packing food during cooking or other handling in excessively hot temperatures. Products made by Aspelin Group do not have official Halal nor Kosher certifications, but no animal-based substances are used in the manufacturing process.

This Declaration of Compliance is based on and is in accordance with our suppliers' declarations.
